## Mozambican refugees in Malawi: Livelihoods and their impact on the natural resource base

In his paper on 'Mozambican Refugees in Malawi', Dr. Chris Barnett of ITAD, explores the relationship between refugee livelihoods and natural resources, and in particular the 'transforming processes and structures' by which refugees gain access to (and impact on) the local environment.

The findings show that refugee livelihoods had a limited longer-term impact on the environment, though there were important local differences as well as appreciable changes in the availability of fuelwood in the Dedza and Ntcheu districts of Malawi.

# Livelihood Options in Refugee Situations - UNHCR's handbook for sound agricultural practices

In December 2002, UNHCR's Environmental Unit, Engineering and Environmental Services Section and CARE International developed a handbook for sound agricultural practices in refugee and returnee situations. The handbook presents options and approaches for crop

## Refugee Operations and Environmental Management - selected lessons learned

As part of the TSEMPRAA (Towards Sustainable Environmental Management Practices in Refugee Affected Areas) activities UNHCR developed a sourcebook on lessons learned and environmental practices of past refugee operations. 'The lessons build on a variety of successful and unsuccessful attempts in field operations to mitigate negative environmental impacts'.

This sourcebook is intended as a technical tool to help inform and guide practitioners of the various environmental issues, guidelines and management issues encountered in refugee operations.

# Refugees and local hosts in Zambia - sharing natural resources between refugees and their hosts

An article written for ID21 Insights explored the relationship between Angolan refugees and their Zambian hosts regarding the sharing of natural resources in Zambia. The research revealed that both the refugees and their hosts shared the same livelihoods based on subsistence farming, which was an influencing factor in the Anglolan refugees local integration. Moreover, the article illustrates the productive relationships that exist in situations where there are mutual benefits to both the refugees and their host communities.
