
- Area- 8,886 sq miles

## ROLES AND RESPONSIBILITIES OF KEY PLAYERS

- Identification of vulnerable persons
- Provision of legal, employment, medical, psychological, protection services
- Provision of legal status during duration of stay in country
- Investigation and prosecution of any perpetrators/exploiters & in tandem with regional partners where applicable

\*Victim sensitive approach

\*Adherence to Confidentiality





## LEGISLATIVE FRAMEWORK FOR MIXED MIGRATION

- IMMIGRATION ACT-CHAPT4ER 156
- REFUGEE ACT CHAPTER 165
- TRAFFICKING IN PERSONS PROHIBITION ACT 2013
- VARIOUS INTERNATIONAL CONVENTIONS





### Operational Mechanism for Asylum Seekers

- Person (s) attempts to enter country and declares at the point of entry that they are seeking Asylum or indicators are observed.
- Main reasons includes:
- Political or Religious persecutions
- Extortion from Gangs
- Human Trafficking
- Person(s) is interviewed by Immigration Officials/Police Personnel.
  They are then referred to Help for Progress (refugees)/Operations
  Sub-Committee-ATIPS(trafficking) / Department of Human
  Services(unaccompanied minors)
- An evaluation/assessment is conducted to include:
- Interview
  - Statement Taking
- Evidence gathering etc.



## Operational Mechanism for Asylum Seekers Con't

- Request for further investigation from other relevant authorities:
- Immigration
- Police
- Human Services
- Embassies
- Person (s) presents himself/herself to Immigration Department along with reference letter from Help for Progress/Other Authorities.
- Person is interviewed and findings are recorded.
- Statement is then taken and is signed.
- Any other evidence is then gathered.
- Person (s) are provided temporary legal status

### OPORTUNITIES FOR ENHANCING ASYLUM PROTECTION CAPACITIES

- Committees formulated by legislation provides guidance for operationally working together.
- Eligibility Committee Refugee Act
- Anti Trafficking in Persons Council
- Integrate core training curriculums for vulnerable persons into key agencies in-service training plans/programs
