The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950 by the United Nations General Assembly, requests your price quotation for Local transportation services from UNHCR warehouses to the different locations as indicated in the attached financial offer.

1. REQUIREMENT

Type of services deliverables: Establishment of frame agreement for the local transportation services.

- Loading locations: As indicated in the Annex A- financial offer.
- Offer validity period: 45 days.
- Frame agreement period: 1 year
- Company registration documents with the Government of Egypt.
- Submit copy of your company's Tax registration certificate (VAT).
- Proof that your company was established and has been selling similar services for 3 or more years prior to the closing date of this Request for Quotation.
- Cost of the services all inclusive and the loading and off-loading process.
- Unit Cost should be without tax + the percentage of the applicable VAT/Taxes.

Please include the following information in your quote:

- Filled in, signed and stamped financial offer form (Annex A).
- Filled in, signed and stamped Vender Registration Form (Annex B).
- Acceptance, by signing and stamping, UNHCR's General Conditions for the provision of Goods and Services (Annex C) and UN Supplier Code of Conduct (Annex D).
- Currency of your offer should be USD.

2. RFQ SUBMISSION

Your quotation must be submitted by **15 July 2023 23:59 Hrs. Egypt time** by e-mail in PDF format to. arecasup@unhcr.org & alkanane@unhcr.org (please make sure to copy the two mails while applying for the RFQ)

3. VENDORS ON UN, UNGM, EU SANCTION LIST:

Companies/vendors who are currently on the list of ineligible (blacklisted) vendors in any of the above sanction lists need not submit offers/proposals against any of UNHCR's Request for Proposals or Invitation to Bid or Request for Quotation as they will not be accepted but disqualified outright. LATE SUBMISSION OF BIDS: Bids received after the deadline for submission of bids and bids transmitted in any other manner than those indicated above may not be considered.

BID ACCEPTANCE: UNHCR reserves the right to accept the whole or part of your bid. The lowest tender needs not to be accepted.

BID VALIDITY: You are requested to hold your proposal valid for **45 days** from the deadline for submission. UNHCR will make its best effort to select a firm within this period.
