PROGRAMME BUDGETS AND FUNDING IN 2004 AND PROJECTIONS FOR 2005

I. INTRODUCTION

1. UNHCR's Annual Programme Budget for 2004 (revised) and the 2005 initial budget were presented to the Executive Committee in October 2004 (A/AC.96/992 and Corr.1 and Add. 1 and 2). The tables that accompany the present document provide further updated information on programme expenditure and funding in 2004 (Annex I), a list of transfers from the 2004 Operational Reserves Categories I and II (Annexes II and III), a summary of current programme funding requirements for 2005 (Annex IV), a list of 2004 contributions (Annex V), and a list of major refugee-hosting countries and related data, in recognition of their important contribution to protecting and assisting refugees (Annex VI). A further table, by way of an example of future reporting on the Operational Reserve Category II, shows the transfers to date in 2005 (Annex VII). A draft decision is proposed (Annex VIII) for adoption by the Standing Committee. The following paragraphs provide additional explanations on the above.

II. PROGRAMMES, FUNDING AND EXPENDITURE IN 2004

- 2. Total requirements approved by the Executive Committee for 2004 amounted to \$954.9 million, comprising \$922.9 for the Annual Programme (including \$60.9 million and \$50 million respectively for Operational Reserve Categories I and II), \$25.0 million for the United Nations Regular Budget and \$7 million for Junior Professional Officers (JPOs); see Annex I, column 1. During the course of 2004, the requirements for the United Nations Regular Budget and for JPOs were increased respectively to \$27.7 million and \$8 million. Together with total Supplementary Programme Budgets amounting to \$278.0 million, the combined budgetary requirements for 2004 were \$1,236.6 million (see Annex I, column 2).
- 3. On a preliminary basis, projected total 2004 income with adjustments is \$1,019.3 million with total projected expenditures for the Annual Programme Budget amounting to \$909.6 million (including \$27.7 million under the United Nations Regular Budget and \$7.9 million for JPOs). Under the Supplementary Programme Budgets, a provisional projection of total expenditures is \$152.0 million. Together with the 2003 carry-over amounting to \$105.2 million, the 2004 closing balance is estimated at \$62.9 million. Details of total expenditures for activities

programmed in 2004 and income received for the year, including funds carried over from 2003, are provided in Annex 1. Final income and expenditure figures will only be known at the time of the publication of the 2004 accounts, expected by end February. Thus, all income and expenditure figures are provisional. Additional details on 2004 expenditure will be provided in the introductory statement to this document.

A. Annual Programme

- 4. The 2004 Annual Programme Budget approved by the Executive Committee in October 2003 (A/AC.96/979) amounted to \$922.9 million. As a precaution against potential funding shortfalls, the High Commissioner, in early 2004, imposed caps on the programme and support budgets. Thus, programme budgets were capped at 95 per cent and non-staff administrative costs budgets were capped at 90 per cent. These measures required reprioritization at both the field and headquarters levels to identify activities for potential non-implementation amounting to \$36 million.
- 5. The mid-year review of total operations in 2004 confirmed that the continuing projected funding shortfalls and an accelerating weakening of the US dollar would require a very careful management of expenditures in relation to income received. While this reduced the High Commissioner's flexibility in addressing new developments and in the management of UNHCR's field operations, the mid-year review nevertheless allowed for a number of budgetary adjustments, while still ensuring that total expenditures would remain within projected income and that revised budgets could be fully obligated.
- 6. With a carry-over from 2003 of \$76.2 million, \$793.9 million in contributions and \$17.9 million derived from other income and adjustments, \$888.0 million were available under the 2004 Annual Programme Budget.
- 7. Total expenditures under the Annual Programme Budget for 2004 are provisionally estimated at \$874.0 million, leaving an estimated carry-over to 2005 of \$14.0 million. While the carry-over into 2004 was considerably higher, due mainly to exchange rate gains, the projected carry-over into 2005 reflects UNHCR's efforts to balance expenditures against projected income and to end the year with a carry-over at a more reasonable level. However, as stated above, final 2004 figures and details of the composition of expenditures and income will only be known upon presentation of the final set of accounts by the High Commissioner.
- 8. As concerns the Operational Reserve, the High Commissioner introduced on a trial basis a revised structure in the budget for 2004. The Operational Reserve Category I was established at 7.5 per cent of the proposed programme activities. Category II was initially set at \$50 million to be used exclusively to accommodate additional contributions for expanded or new activities that were considered as falling within the Mandate of the Office, but which were not included in the Annual Programme Budget. During the 31st meeting of the Standing Committee in September 2004, UNHCR reported favourably on the way the mechanism was functioning.

The trial period was extended for one year by the Executive Committee in October (A/AC.96/1003, para 24). At the same time, a request for an independent evaluation of the Operational Reserve Category II was made. The evaluation was commissioned, the results of which should be presented to the Standing Committee at its 32nd meeting. By way of an example of possible future reporting on Operational Reserve Category II, Annex VIII shows transfers to date in 2005.

9. Transfers from the 2004 Operational Reserves are shown in Annexes II and III. A total of \$38.6 million, or 63 per cent, of the Operational Reserve Category I was allocated across all regions in the course of the year (excluding loans to Supplementary Programme Budgets), while under the Operational Reserve Category II, a total of \$24.6 million, or 49 per cent, was allocated.

B. Supplementary Programme Budgets

- 10. Total requirements for Supplementary Programme Budgets in 2004 amounted to \$278.0 million (see Annex I, column 2). With a carry-over from 2003 of \$21.8 million, \$157.4 million in contributions and \$12.6 million derived from other income and adjustments, \$191.8 million were available under the 2004 Supplementary Programme Budgets. Estimated expenditure stands at \$152.0 million, resulting in a projected carry-over of \$39.8 million.
- 11. Two of the Supplementary Programme Budgets, for the Return and Reintegration of Sudanese Refugees to Southern Sudan, and for the Return and Reintegration of Burundian Refugees, were started after 30 June 2004 and as such have continued with supplementary programme budget status for 2005. Two other Supplementary Programme Budgets, for the Iraq Operation and for Emergency Assistance for Eastern Chad and Darfur, are exceptionally being continued as Supplementary Programmes in 2005 (see Annex IV).

III. OVERALL PROGRAMME AND FUNDING PROJECTIONS FOR 2005

- 12. At its fifty-fifth session in October 2004, under the 2005 Annual Programme Budget the Executive Committee approved the amount of of \$862.1 million for programmed activities (see Annex IV), including an allocation of \$28.7 million from the United Nations Regular Budget. Additional provisions were approved under the Operational Reserve Categories I and II of \$112.5 million, comprised of \$62.5 million, or 7.5 per cent of the programme activities under Operational Reserve I, and \$50 million under Operational Reserve II. The Executive Committee also took note of \$7 million in budgeted activities for JPOs, bringing total requirements to \$981.6 million (A/AC.96/992).
- 13. Measures have again been taken in 2005 to prepare for a possible funding shortfall under the Annual Programme Budget. A five per cent "freeze" on the 2005 Executive Committee approved Annual Programme Budget has been introduced on all programme budgets and non-staff administrative costs. Bureaux and Divisions have retained the flexibility to allocate the reduction within their area of responsibility to effect a minimal impact on operations.
- 14. In addition to the four Supplementary Programme Budgets mentioned in paragraph 11 above, and since the approval of the Annual Programme Budget for 2005, two additional Supplementary Programme Budgets have been approved: Indian Ocean Earthquake/Tsunami

Emergency (\$75.9 million) and Repatriation and Reintegration of Congolese Refugees (\$15.6 million), bringing the current total budget for 2005 Supplementary Programmes to \$369.0 million.

- 15. The combined 2005 Annual and Supplementary Programme Budgets thus currently amount to \$1,350.6 million.
- 16. While UNHCR's financial situation remains relatively stable, and while donor response at the December 2004 Pledging Conference confirmed a sustained commitment to supporting vital refugee programmes throughout the year, UNHCR is concerned that the relatively low projected carry-over into 2005 under the Annual Programme Budget, as well as the possible reduction in potential funding due to the response to the Indian Ocean Tsunami crisis, may reduce funds available for the 2005 programmes. In light of the extensive needs to be addressed by the Office of the High Commissioner, donors are therefore urged to respond generously, in a spirit of solidarity and in a timely manner, to his appeal for resources to meet in full the approved 2005 Annual Programme Budget, as well as the requirements of the 2005 Supplementary Programme Budgets.

DRAFT DECISION ON PROGRAMME BUDGETS AND FUNDING IN 2005

The Standing Committee,

Recalling the Executive Committee's decision at its fifty-fifth session on administrative, financial and programme matters (A/AC.96/1003, para. 24) as well as its discussions under the programme budgets and funding item at the thirty-first meeting of the Standing Committee,

Reaffirming the importance of international burden and responsibility-sharing in reducing the burden of host countries, especially developing ones,

- 1. *Notes* that UNHCR's overall needs under its Annual Programme for 2005, based on currently known requirements, amount to US981.6 million, as approved by the Executive Committee at its fifty-fifth session (which included \$28.7 million from the United Nations Regular Budget and \$7 million for Junior Professional Officers);
- 2. *Notes* that the 2005 Supplementary Programme Budgets currently amount to \$369 million;
- 3. Recognizes that emergencies and unforeseen activities unfolding during 2005 may result in the need for additional or expanded Supplementary Programmes and that additional resources, over and above those for existing budgets, would be needed to meet such needs;
- 4. *Notes with continuing concern* that the High Commissioner has been compelled to reduce the activities under the Annual Programme Budget in reaction to anticipated funding shortfalls; and
- 5. *Urges* Member States, in light of the extensive needs to be addressed by the Office of the High Commissioner, to respond generously and in a spirit of solidarity, and in a timely manner, to his appeal for resources to meet in full the approved 2005 Annual Programme Budget, as well as the requirements of the 2005 Supplementary Programme Budgets.
