## Central African Republic

To address the needs of newly replaced refugees from the Democratic Republic of the Congo in Central African Republic, UNHCR has revised its 2010 operations plan and budget. These new plans and budget require additional resources of almost USD 6 million above those originally outlined in UNHCR's Global Appeal for 2010-2011.

Central African Republic (CAR) currently hosts about 30,000 new Congolese refugees and asylum—seekers who recently arrived from the Democratic Republic of the Congo (DRC). In November 2009, the volatile situation in the Equateur Province in DRC, mainly in Dongo, prompted the flight of thousands of people from the Gemena and Dongo area into CAR. The majority of the new arrivals reached Mougoumba and UNHCR has registered almost 17,000 individuals.

Refugees indicate they fled out of fear during the escalation of violence in their home areas. They feared violence, including rape and looting which characterized previous internal conflicts. They sought refuge in CAR pending the stabilization of the situation in DRC. Most of the population originally living in the villages between Gemena and Dongo has left and is now in CAR. The continuous influx of new arrivals in the prefecture of Lobaye

is likely to increase the number of the Congolese refugees.

Furthermore, earlier in June 2009, about 7,500 people, mostly from the Eastern province of DRC arrived in Obo, Mboki and Zémio. They fled insecurity, threats and attacks against their villages, killings, abductions and looting perpetrated by Lord's Resistance Army (LRA) rebels.

#### The needs

The area where refugees are being received is in the forest. The only available water source is the Oubangui river, creating the risk of malaria and diarrhea. Therefore, water and sanitation, health care, food, education, camp management, registration and profiling are the priority needs as outlined in reports of the inter-agency

assessment missions conducted in the prefectures of Haut Mboumou and Lobaye in November and December 2009.

Although the majority of this population is composed of farmers, fishermen and their families, there are also some civil servants, including agronomists,

teachers, professors, and nurses.
About 40 per cent of the population consists of school-aged children who require education. Elderly people, pregnant women, persons with disabilities and other vulnerable persons will also require special attention.

#### Strategy and activities

UNHCR began immediately providing emergency assistance to 30,000 refugees in Lobaye and Haut Mbomou. Simultaneously, the Office negotiated with local authorities to identify land for refugee settlements and carried out technical assessment and site planning. Three potential sites have been identified and camp construction and establishing a camp management structure at Mongoumba (Lobaye) and

Zemio (Haut Mbomou) is ongoing. Refugees will be relocated to the newly constructed camp. Community mobilization and participation in all aspects of the project will be promoted.

UNHCR's programme is coordinated and implemented closely with the Government of CAR (Commission Nationale pour les Réfugiés), other UN agencies and NGOs

#### **UNHCR** is implementing following activities:

- Maintaining international standards of protection and assistance for all people of concern;
- Registration and profiling of all refugees and asylumseekers;
- Protection monitoring through regular field visits and a reporting system;
- Provision and distribution of basic domestic items. To the date, 3,200 plastic sheets, 240 tents, 6,600 sleeping mats, 4,400 jerrycans, 1,800 kitchen sets, 2,870 buckets and 9,300 mosquito nets have been distributed;
- Negotiations for land for refugee camps, technical assessments, site planning and development;

- Improvement of conditions and services in the newly constructed refugee camps; two sites in Mougoumba and one site in Zémio (Haut Mbomou);
- Transfer of refugees to the newly constructed camps;
- Construction of new latrines to maintain minimal sanitary conditions and hygiene;
- Provision of seeds, agriculture tools and fishing nets;
- Strengthen partnerships among stakeholders including Government, implementing and operational partners, UN agencies, national and international NGOs to provide effective protection and assistance; and
- Provision of access to services for the host community to support peaceful co-existence.

#### Key targets for 2010

- 30,000 refugees have access to timely registration, effective protection and legal assistance;
- Field visits undertaken regularly to monitor protection situation;
- All new arrivals are documented and receive basic domestic items;
- Sufficient land granted by the government for refugee settlement and crop production;
- Shelter and other community infrastructure rehabilitated or constructed;
- Community-based approach strengthened in the implementation of the project;
- Maintenance and/or extention of the basic social services facilities, such us water supply system, sanitation, health care and education facilities; and
- All fishermen and farmers resume their usual livelihoods.
