Funding requirement

Under the current circumstances in Yemen, the situation of refugees, asylum seekers and migrants has become even more tenuous and has further exacerbated their vulnerabilities. UNHCR estimates that there are 9,000 asylum seekers and 118,000 refugees and IOM estimates 650,000 of migrants in Yemen. Unlike Yemeni citizens, these communities lack traditional safety-nets and as needs grow and resources dwindle are less able to rely on the long-standing generosity that Yemenis have accorded to them. Reports have started to be received of refugees and asylum seekers encountering protection incidents on account of being foreign nationals. In addition, these populations may be forced to move and will be at greater risk of smuggling and trafficking. UNHCR currently has partners patrolling the Arabian Sea and Bab-el-Mandab coast with reception facilities and identification processes for asylum seekers. However, the capacity has been affected owing to the current situation, particularly owing to the lack of fuel and the security situation. Given these factors it is imperative that services to refugees, asylum seekers and migrants continue in order to ensure their protection and sustenance.

Core areas of work

- 1: Life-saving protection, including food, water, medical care and temporary shelter for refugees and migrants.
- 2: Evacuation of stranded third-country nationals (migrants).
- 3: Provision of protection services, including child protection, GBV response and detention related interventions.
