4.2 Content of the EOI:

The EOI must include, as a minimum, the following documentation / information:

- o Companies' registration certificate and licenses, in case of individual property of the suggested sites, Proof of ownership has to be submitted such as title deed (الملكية سند) or a recent Statement ofProperty (عقارية افادة) or else;
- o Companies'/Landlords' contact details (address, telephone and fax numbers, email, etc.)
- Suggested building and land location and name
- A full description of the suggested building/land such as:
 - Spreadsheets of surfaces in square meters or square feet
 - Floor plans, sections, elevation drawings
- General Information on rental conditions, including rental price per square meter and any other applicable charges such as service/maintenance and parking fees (if not included in the rent).
- Dully filled and signed Annex A and B.

UNHCR will review the responses and may seek further clarifications and information from certain respondents. These requests for clarifications or information may take the form of communication by telephone, in writing or e-mails. UNHCR will not bear any costs relating to the preparation and submission of the EOI responses.
