- **Language:** Bids shall be prepared in English.
- **Currency:** Your quote shall be in US\$.
- **Prices:** Unit price must be provided excluding VAT and it must be “**all-inclusive**” price, including delivery.

Accordingly, to ensure that sufficient information is available, the bidder shall furnish, as part of the offer, any descriptive material such as extracts, descriptions, and other necessary information it deems would enhance the comprehension of its offer.

**Late submission of bids: Bids received after the deadline for submission of bids may not be considered.**

**Bid acceptance:** UNHCR reserves the right to accept the whole or part of your bid. The lowest tender needs not to be accepted.

**Bid validity:** You are requested to hold your quotation valid for 60 days from the deadline for submission. UNHCR will make its best effort to select a firm within this period.
