### **3. BID EVALUATION:**

All bids will be evaluated based on compliance with the established UNHCR Requirements and delivery terms and price.

### **4. BIDDING INFORMATION:**

- **Language:** Bids shall be prepared in English.
- **Currency:** Your quote shall be in US\$.
- **Prices:** Unit price must be provided excluding VAT and it must be “**all-inclusive**” price.

UNHCR will not be responsible for locating or securing any information that is not identified in the offer. Accordingly, to ensure that sufficient information is available, the bidder shall furnish, as part of the offer, any descriptive material such as extracts, descriptions, and other necessary information it deems would enhance the comprehension of its offer.

**Late submission of bids: Bids received after the deadline for submission of bids may not be considered.**

**Bid acceptance:** UNHCR reserves the right to accept the whole or part of your bid. The lowest tender needs not to be accepted.

**Bid validity:** You are requested to hold your quotation valid for 30 days from the deadline for submission. UNHCR will make its best effort to select a firm within this period.

**Payment:** Payment will be made within 30 days of receipt of invoice at UNHCR Office in Beirut following satisfactory delivery of goods/services. UNHCR does not undertake to pay by letters of credit or in advance of delivery.
