This revised edition of the 'The Birth of the Palestinian Refugee Problem, 1947-1949' revisits the 1948 war and the Palestine exodus on the basis newly opened Israeli military archives and intelligence documentation. Drawing on previously classified primary and archival sources, the author discusses the myths and realities of the exodus, what happened in Jerusalem, Jaffa and Haifa, and how these events led to the collapse of Palestinian urban society. The study proceeds chronologically, from the UN General Assembly Partition Resolution, 1947, to the collapse of the Lausanne peace conference in 1949. In examining the exodus, the study proceeds geographically, from area to area. The study contains three maps detailing the UN Partition Plan of November 1947; the Arab settlements abandoned in 1948-9 and the date and main causes of abandonment; and the Jewish settlements established in the same year. The maps are followed by extensively detailed keys.

The definition of return also includes the processes leading to returns. The geographic regions covered include Ethiopia, Eritrea, Rwanda, Nicaragua, Barbados, the Balkans, Germany, China, Vietnam and the Philippines.

This book draws upon political and ethical theory and examines the experiences of the US, Germany, the UK, and Australia to see how they respond to the challenges of asylum. The author brings together the ethical and practical lessons learnt. This edited collection investigates the controversial debate on humanitarian intervention in international society in theory and practice. Underlining the debate is the alleged tension between the principle of state sovereignty and international law, and the evolving international norms related to human rights and the use of force. The book includes chapters by scholars of law, philosophy and international relations, as well as contributions from those actively engaged in instances of intervention in the past decade. The cases covered include humanitarian intervention which took place in the early years of the post cold war period, such as Somalia, Rwanda, Bosnia, the Balkans and East Timor, as well as the recent US intervention in Afghanistan. There are three themes that unify the book. The first is the expansion of intervention. While very few interventions for humanitarian purposes occurred during the cold war, the 1990s witnessed a series of armed humanitarian interventional relations. Second, despite the frequency of these interventions, they continue to be a controversial norm in international relations. The third theme is that humanitarian interventions are plagued by problems of will and capacity and have the potential to divide international institutions, like the UN, western states and humanitarian organizations and damage their credibility.

Children separated from their families because of armed conflict, population displacements or natural disasters are amongst the most vulnerable to abuse and exploitation. The breakdown of social structures and services within communities and states make it imperative that humanitarian organizations ensure the protection of these children. The range and complexity of situations in which children get separated from their families demand complimentary skills and mandates of different agencies for a concerted and effective response. The Inter-Agency working Group set up in 1995 developed the Guiding Principles set in this publication for the purpose of guiding future action based on international human rights and humanitarian and refugee law. They seek to ensure that all actions and decisions taken concerning separated children are anchored in a protection framework and respect the principles of family unity and the best interests of the child. These guiding principles are intended primarily for national, international and non-governmental organizations concerned with separated children.

The essays included in this book are written from the perspective of an immigration lawyer and a political activist opposed to immigration controls. Asylum immigration controls in the UK may have changed form but increased in content post-Cold War and after 9/11. These controls impinge on an immigrati's entitlement to welfare and social provisions. The book begins by explaining the new Nationality, Immigration and Asylum Act and the link between education entitlement and immigration status. The authors provide a historical and political background to immigration controls and demonstrate that these controls are, unfortunately, always racist. Historically, starting from the 1905 Aliens Act, they have always been used against refugees. The authors examine the internal welfare controls and look at their international implications of erecting a global fortress against migrants, immigrants and refugees. They conclude by looking critically at the arguments for 'fair' controls and for no immigration controls.

This book examines the role of memories and perception in Palestinian society and politics, particularly amongst Palestinian refugees, and the challenges that these pose in working towards a secure and sustainable peace between Israelis and Palestinians. The objective of this book is to study the impact of Palestinian refugee mythologies on the ability of external parties to reshape the political environment between the two sides and on their implications for the longer-term outlook on the Palestinian refugee issue and on the work of the UNRWA. The analytical concerns addressed in this book fall under two general headings. First, they discuss the nature of memories and mythologies of Palestinian refugees and how they affect peace negotiations. It studies Israeli law and policy surrounding the refugees and questions Israel's moral and legal responsibility towards Palestinians. Drawing on previously classified primary and archival sources, the author discusses the 1948 exodus and myths and realities surrounding the exodus; Israeli resettlement schemes and investigates the ideological, political, economic, diplomatic, public relations and psychological factors which motivated Israeli resettlement schemes in the 1950s; Israeli approaches to compensation and restitution of property; Israeli policies towards the 'present absentees' or internally displaced; and Israeli refugee policies during the Madrid and Oslo negotiations. This book focuses on the history of abandoned Palestinian refugee property during the first Arab-Israeli war in 1948, the expropriation of this property by the Israelis and its ongoing implications in the wider Arab-Israeli conflict as one of its core unresolved issues. The refugees' plight emerged not only as the central challenge for the world community but also the Arab-Israeli conflict's most intractable problem. The flight of the refugees was the direct result of partition of Palestine and affected the socio-economic and political status of almost half of the Palestinian population forced to leave their homes. This book details the extent of Arab property left behind and how it was used by the fledgling state of Israel. It traces the subsequent details of diplomatic activity on the issue and reveals UN estimates of the scope and value of refugee property.

The book contains two appendices. The first presents a comparison of studies on the scope and value of refugee property and the second details a chronology of events relating to refugee property.

Return migration has in the past decades emerged as a critical element of many governments' migration policy to prevent and deter irregular migration and residence. Experience has shown that voluntary and involuntary returns are interlinked and have a mutually reinforcing effect. They maintain the integrity of asylum systems and regular immigration programmes and help create productive bilateral relations between countries of origin, transit and destination. This IOM report studies the policies, laws and practices of voluntary and forced return migration of the EU Member States and Norway and Switzerland. This book attempts to explain the origins of Sudan's multiple and recurring civil wars and their current expansion from southern Sudan to other parts of the country and across international borders. In this book the author examines the economic and political patterns which have affected the development and exercise of state power in the Sudan since the 19th century to explain the process and consequences of regional underdevelopment and the conjunction between perceptions of religion and race specific to this region. The post-independence definition of Sudanese nationalism, rooted in Islam and Arabism, alienated other ethnic groups who demanded secular ideologies based on equal citizenship rights. Cold war rivalries, neighbouring states, foreign relief and developmental agencies, and international oil companies further impacted the war's direction and duration. Two decades of hostilities have broken the bounds of North-South, Arab-African and Muslim-non Muslim conflict and this overall civil war is today composed of interlocking struggles. Now the process of self-determination needs to accommodate demands for greater self-government for the Sudanese regions. In its appendix, the book contains a chronology of events since 1972 to 2002 and a bibliographic essay on published literature and agency reports on Sudan.

The increase in crime of trafficking in persons has been facilitated by globalization. This internationalization generates consequential problems for the persecution of this crime as state sovereignty and national competences are not sufficient to prosecute and to combat it adequately. The aim of this study is to identify the obstacles to the use of policy documents and legal instruments adopted to suppress and persecute trafficking in persons in order to improve the prosecution of alleged traffickers. This study focuses on the European Union and in seeking to clarify obstacles suggests an approach at the EU level for more effective prosecution of those involved in human trafficking based on the concept of regional jurisdiction. It also discusses the relative effectiveness of recently developed instruments and initiatives within the EU like the European Arrest Warrant, Eurojust and the appointment of the European Public Prosecutor. The study recommends a dual-track approach of new initiatives and in the modification of the use of current principles to best deal with this transnational crime.

Unauthorised and irregular migration in Southeast Asia has seen an unprecedented rise. The growing integration of the region's economies, demographic and economic differentials between countries as well as a shared history, culture, geography, social network and migration industry have all contributed to this phenomenon. Illegal migrants, though they may appear as violators, originate from similar causes and determinants as legal migrants. Where the two groups diverge is in the access to migration channels. Those that go through irregular channels become more vulnerable to abuse and inhuman treatment in the country of destination. Migration policies, regulations and employment practices of the sending and receiving countries can influence the possibility of legal or irregular migration. Based on studies in two countries of origin, the Philippines and Indonesia, and two countries of destination, Malaysia and Thailand, the book explores the reasons behind the high levels of irregular migration in Asia. It reviews existing migration policies both in countries of origin and of destination and examines specific policies against irregular migration. It investigates the dynamics of irregular migration, particularly the role played by employment agencies and intermediaries, and the employment conditions irregular migrants' encounter. The collaborators to this study conclude that a lasting and humane solution rests on regional cooperation and paying due attention to the fundamental causes of migration and the human rights of migrants.
