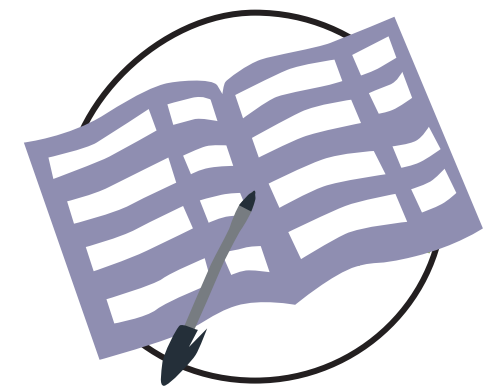

A Registration

Serial No.:

> Enter sequence number in register

HCT No:

> Enter unique client identifying code

Counsellor Code:

> Enter unique counsellor identifying code

Age:

> Enter age (in years)

Sex:

> Enter Male (M) / Female (F)

Status:

> Classify as Refugee (Ref) / National (Nat)

Date of visit:

> Enter date (dd/mm/yy)

Prev. test:

> Enter Yes (Y) or No (N) to indicate whether client has had previous test.

NOTES

HCT Client code and Counselor codes should be ciphered according to Ministry of Health and/or agency guidelines.

Previous test means at any time in any location, including country of origin.

B Test Results

For Pre-test counseled / Tested / Post-test counseled:

> Enter Yes (Y) or No (N) to indicate presence or absence of the event. Leave blank if not indicated.

For Screening / Confirmatory / Tiebreaker tests:

> Enter Positive (P) / Negative (N)

HIV Status:

> Enter Positive (P) / Negative (N) / Indeterminate (I)

Partner HCT code:

> Enter unique identifying code for partner, if client attended as a couple

> Enter location client was referred to using options in the legend:

HCT Results Register

All health information recorded in HCT is confidential. Access to this register should be restricted at all times. Registers should be stored out of public view when not in use, ideally in separate locations that are secured with a lock and key.

The health information system operates under a principle of shared confidentiality. Counsellors should enter results into this register on a “need to know” basis and only counselors and health care providers with a direct role in the management of clients should update individual HCT records.
