The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950, by the United Nations General Assembly, requests your price quotation for the provision of medical services specified in this Request for Quotation (RFQ).

**1. REQUIREMENTS**

- Description: Medical services
- Location: UNCHR Romania (Bucharest, Suceava, Galati, Constanta, Timisoara)
- Duration of Services: Frame agreement for two years potentially extendable for an additional one year (2+1 years).

**2. Contract Award:**

UNHCR may award Frame Agreement(s) with initial duration of 2 (Two) years, potentially extendable for an additional period of 1 (one) year. The successful bidders will be requested to maintain their quoted price model for the duration of the Frame Agreement(s).

The estimated requirement of UNHCR is stated in Annex A. Please note that figures have been stated in order to enable bidders to have an indication of the projected requirements. It does not represent a commitment that UNHCR will require the totality of the above quantity. Quantities May

29, 2024 vary and will depend on the actual requirements and funds available regulated by issuance of individual Purchase Orders against the Frame Agreement.

### **3. Financial Offer:**

Please submit your price offer, using the financial form (**Annex C**). Your offer can be in **LEU**. For financial evaluation purposes only, offers in **other currencies** shall be converted to **USD** using the official UN exchange rate. Your prices must be inclusive of costs like transportation, handling, installation, exchange rates, other risks, and any other cost UNHCR shall not accept any requests for additional payments after reception of your offer.

UNHCR is Tax exempted, in this regard, the price has to be given without VAT.

### **4. Award Criteria:**

The lowest-priced, substantially compliant offer will be recommended for a contract award.

Your quotation must be valid for at least **90 calendar days**. The standard payment terms of UNHCR is net **30 days** upon satisfactory delivery of goods and acceptance thereof by UNHCR.

Please complete and **submit Annex B: Technical Offer form and Annex C: Financial offer form**. Please note that offers with missing Annex A and/or B will not be evaluated.

UNHCR is Tax exempted, in this regard, the price must be given **without VAT**.

Please, ensure to use the format provided (**Annex C**) and that your calculations of the unit and total prices are accurate.
