## STATEMENT OF H.E. MR. MAI PHAN DUNG, AMBASSADOR, PERMANENT REPRESENTATIVE OF VIET NAM AT THE 75TH SESSION OF UNHCR EXECUTIVE COMMITTEE

(14-18 October, Geneva, Switzerland)

## High Comissioner, Madam Chairperson, Excellencies and Colleagues,

First, on behalf of my delegation, I would like to express my congratulations to Madam Chairperson for successfully steering the Executive Committee. We also commend the endless efforts of the High Commissioner and UNHCR to timely respond to large-scale and complex displacement flows. We recognize the sharing responsibility and generosity of all relevant stakeholders in addressing this issue over time.

Since the second Global Regugee Forum, mixed migration flows through different routes have continued to increase because of several drivers including conflicts and violence. To break this cycle, it is crucial to sustain peace and stability, uphold the fundamental principles of international laws and international humanitarian law, address the root causes of displacement, while increasing and accelerating humanitarian assistance to support vulnerable populations. Also, it is important to make a clear and transparent difference between those opting for migration through unsafe channels and those fleeing from crises so that appropriate actions could be delivered in the right direction, not for political purposes.

High Commissioner, for a decade of implementing the # Ibelong Campaign (2014-2024), we are delighted to see a lot of improvements in addressing statelessness across our region as well as in the world. Viet Nam's consistent policy is to ensure everyone's right to have Vietnamese nationality in accordance with Vietnamese law and regulations. During the past 10 years, Viet Nam has also made remarkable efforts in realizing the Global Action Plan to End Statelessness, especially in enhancing the legal system in civil status, nationality and residence. On November 20, 2014, the Law on Civil Status was adopted (effective from January 01, 2016), emphasizing the extremely important role of civil status registration, especially birth registration and putting forth an electronic civil status database connected to National population database to ensure the right to birth registration and a nationality for children. Last November, Viet Nam promulgated

the 2023 Law on Identity (effective from July 1, 2024). This Law allows people of Vietnamese origin with unknown citizenship living in Viet Nam for 6 consecutive months to be granted an Identity Certificate, which is necessary for registering for temporary or permanent residence, participating in civil transactions to benefit from public services as well as essential services, thereby contributing to resolving nationality issues and statelessness.

Currently, we are reviewing the National Action Program on Civil Registration and Vital Statistics for the period 2017-2024 (CRVS Program) to assess the achievement of targets set out in the Program by 2024 including birth registration as a fundamental step to determine nationality. We are also speeding up tasks aimed at preventing statelessness under the Plan on the Implementation of the Global Compact for Safe, Orderly and Regular Migration, including studying the possibility of acceding to the 1961 Convention on the Reduction of Statelessness.

Viet Nam welcomes the launch of the Global Alliance to End Statelessness and believes that with strong and collective actions, the goal will be achieved in this new cooperation mechanism. We would like to take this opportunity to reaffirm our commitments to continuing our efforts to end statelessness and working closely with UNHCR as well as other stakeholders concerned.

In closing, Viet Nam wishes to thank UNHCR for the close cooperation in matters of mutual concerns, especially the valuable support in statelessness prevention. We look forward to tangible outcomes in the next phase of the Global Alliance as well as innovative solutions to effectively and sustainably address the issue of displacement.
