REPLIES TO INQUIRIES

RFP # 023-2018 – PROVISION OF MOBILE COMMAND UNIT

- 1- Mobile command centre equipment list which is in the Annex A, item B is not equal with 'Superstructure unit price list of equipment' in Annex C financial proposal offer form. Please clarify;

Answer#1: Please refer to Annex C (page 2). The lists provided in Annex C represents the entire equipment required for the superstructure.

- 2- Items 8 and 9 are stated as 'UHF Digital Walkie Talkie' and 'Digital Vehicle Walkie Talkie' in the financial proposal form. But these items are defined 'UHF digital radio' and 'digital vehicle radio' in the Superstructure unit equipment list in the Annex B. Please clarify.

Answer#2: Correct. "UHF Digital Walkie Talkie" refers to "UHF Digital Radio" and "Digital Vehicle Walkie Talkie" refers to "Digital Vehicle Radio"

- 3- Superstructure Unit Equipment List which is in the Annex B, is not equal with 'Superstructure unit price list of equipment' in Annex C financial proposal offer form. Please clarify;

Answer#3: Annex C requires the price details for GPS device while Annex B does not include the item, please add the missing item to your Annex B – Technical Proposal Form.

- 4- What is the requested delivery time for chassis and trailers?

Answer#4: The tender dossier does not specify a delivery time, this information is requested from the proposers as part of their technical proposal in their work plan. The proposal on the time frame to complete the project shall be evaluated proportionally and maximum available score from the respective section is 100 point out of 600 point available overall.

- 5- The height of the chassis we plan to offer is 3089mm. It is over the limits described however does not have any functional effect on the trailer. Would it be accepted?

Answer#5: Please refer to Annex A document and ensure your offer is within the tolerable limits (+/-10%).

- 6- Could you please postpone the deadline of proposal submission?

Answer#6: The deadline of the submission is 9 November 2018, it shall not be postponed further.

- 7- Drawing refers to a truck mounted expandable container, and in the specifications 3 axle expandable trailer is referred. Could you clarify why you sent us the drawing of truck mounted container?

Answer#7: The requested of item is Mobile Command Centre with the combination of three axle truck chassis and its expandable superstructure with built-in equipment. Diagrams/Pictures/Drawings used in the specifications are indicative only. They are used to better illustrate and to give an overall idea of the requested item to the potential bidders. Materials demonstrating similar OR BETTER properties may be reviewed and is subject to UNHCR approval.
