The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950 by the United Nations General Assembly<sup>1</sup> requests your price quotation for procurement of goods for support of centers, shelters for persons in life difficult situations (miscellaneous goods, protection from Covid-19) in Annex A in this Request for Quotation (RFQ).

#### **1. REQUIREMENTS**

- Description: 6 categories (LOTs) of Goods as per Annex A. Offers covering all items will be considered with priority. In case if bidders will not be able to cover requirement in full, proposals will be considered by sublots;
- Delivery point: according to Annex A
- Incoterms: DAP
- Delivery time (After receipt of order): up to 14 Calendar Days

- Unit Cost: DAP;
- Cost of all items/goods;
- Cost of Freight;

- Certificates for goods.
